**RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF MAGNOLIA  
PROVIDING FOR THE INSERTION OF A SPECIAL ITEM OF REVENUE IN THE 2021  
BUDGET OF THE BOROUGH OF MAGNOLIA PURSUANT TO N.J.S.A.40A:4-87 (CHAPTER  
159, P.L. 1948) BEING AWARDED \$2,308.54 FOR FY2021 DRUNK DRIVING ENFORCEMENT  
FUND GRANT**

**WHEREAS**, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

**WHEREAS**, said Director may also approve the insertion of any item of appropriation for equal amount; and

**WHEREAS**, the Borough of Magnolia has received a grant award in the amount of Two Thousand Three Hundred Eight dollars and Fifty-Four cents (\$2,308.54) Reserve for FY2021 Drunk Driving Enforcement Fund Grant to be used for Drunk Driving Enforcement and wishes to amend its 2021 Budget to include this amount as a revenue; and

**NOW, THEREFORE, BE IT RESOLVED** that the Borough of Magnolia hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget for the year 2021 in the amount of Two Thousand Three Hundred Eight dollars and Fifty-Four cents (\$2,308.54) which item is now available as revenue under the caption of:



**FY2021 DRUNK DRIVING ENFORCEMENT FUND GRANT, and**


**BE IT FURTHER RESOLVED** that the above is the result of monies received from the State of New Jersey.


