**RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF  
MAGNOLIA AUTHORIZING MONTH TO MONTH CONTRACTS (BID A-48/2020, 6  
MONTH OPTION), BY AND BETWEEN THE BOROUGH OF MAGNOLIA AND  
VARIOUS VENDORS FOR THE PROVISION OF COPY PAPER, COMPUTER PAPER AND  
ENVELOPES UNDER THE CAMDEN COUNTY PRICING SYSTEM IDENTIFIER #57-  
CCCPS, ON AN "AS-NEEDED" BASIS, PENDING RE-PROCUREMENT**

**WHEREAS**, by Resolution No. 2021-81 adopted April 07, 2021, the Borough of Magnolia authorized the 6 month option of Bid A-48, 2020, for Copy Paper, Computer Paper and Envelopes under the Camden County Pricing System Identifier #57-CCCPS, on an "as-needed" basis to the vendors and items listed on the schedule attached hereto, for the term commencing April 1, 2021 through September 30, 2021; and

**WHEREAS**, the 6-month option will expire on September 30, 2021; and

**WHEREAS**, the County of Camden acting as lead Agency received bids for Copy, Computer Paper and Envelopes, Bid A-48/2020; and

**WHEREAS**, pending the award of bid for said services, the Borough agrees to extend the current 6 months option contracts on a month to month basis with the same terms, rates and conditions in accordance with N.J.S.A. 40A:11-15.


