
**RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF



**BE IT FUTHER RESOLVED**, that the term of this agreement shall be from January 1, 2022 through December 31, 2024.

**SHARED SERVICE AGREEMENT BY AND BETWEEN THE BOROUGH OF  
RUNNEMEDE AND THE BOROUGH OF MAGNOLIA FOR STREET SWEEPING IN  
LIEU OF MECHANICAL WORK & OTHER PUBLIC WORKS RELATED GOODS AND  
SERVICES**


THIS SHARED SERVICES AGREEMENT is effective the 1<sup>st</sup> day of January, 2022 between The Borough of RUNNEMEDE, a municipal corporation of the State of New Jersey and The Borough of MAGNOLIA, a municipal corporation of the State of New Jersey;

The purpose of this Agreement is for Runnemedede to provide sweeping service in exchange for labor on mechanical services, this agreement shall also provide other related goods and services by the attached equipment and labor schedule.


1. This Agreement shall take effect January 1, 2022 and expire December 31, 2024.
2. Either party may terminate this agreement prior to expiration of the term upon 60 days advance written notice to the other party.
3. Runnemedede shall provide as-needed sweeping and other Public Works related goods and services to the Borough of Magnolia according to the terms and conditions set forth below.
4. Runnemedede shall charge Magnolia for the above goods and/or services as follow:
  - a. On an as-needed basis, where proposal will be provided by Runnemedede for specific goods or services by attached equipment and labor schedule.
  - b. Sweeping services will be calculated and reimbursed in mechanic labor on servicing Runnemedede Vehicles.
5. Runnemedede shall provide Magnolia with itemized monthly billings. Payment for goods and other services shall be due from Magnolia within 30 (thirty) days of the date of billing.

IN WITNESS WHEREOF, parties of the Agreement have caused it to be signed by the proper officers and their corporate seals to be affixed as of the day and year set forth.




