**RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MAGNOLIA  
AUTHORIZING AN AWARD OF CONTRACT, BY AND BETWEEN THE COUNTY OF  
CAMDEN AND FCR CAMDEN, LLC, RFP #22-19, FOR MARKETING SERVICES OF  
SINGLE-STREAM RECYCLABLE MATERIALS UNDER THE CAMDEN COUNTY  
COOPERATIVE PRICING SYSTEM ID #57-CCCPS**

**WHEREAS**, the Camden County Board of Chosen Freeholders, as the Lead Agency for the Camden County Cooperative Pricing System, Identifier #57-CCCPS, advertised for the marketing of single-stream recyclable materials for the County of Camden and participating County Municipalities, RFP #22-19, for a term of 3 years, with 2 one-year options to renew, said options to be exercised at the sole discretion of the County; and

**WHEREAS**, the contract was awarded to FCR Camden, LLC from May 1, 2022, through April 30, 2025, at the unit prices listed in its proposal at \$30.00 per ton; and

**WHEREAS**, it is the desire of Mayor and Council to acknowledge the contract awarded above for the items listed herein intended to be used for the Borough of Magnolia's needs; and

**WHEREAS**, funding for this purpose shall be contingent upon the availability and appropriation of sufficient funds for this purpose in the 2022 permanent budget and 2023 temporary and/or permanent budgets and shall be encumbered at the unit price as materials, supplies, and/or equipment services are utilized pursuant to N.J.A.C. 5:30-5.5(b)(2) and said services in the aggregate may not exceed any department's maximum line-item budget for single-stream recyclable material services.




