**RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF
MAGNOLIA AUTHORIZING EMERGENCY AWARD OF CONTRACT – R.D. ZEULI,
INC. – SANITARY SEWER MANHOLE REPAIRS**

WHEREAS, three (3) sanitary sewer manhole castings within the traveled way of White Horse Pike (US Route 30) in the Borough of Magnolia, New Jersey have begun to fail and have sunken into the surrounding roadway, presenting an imminent danger to the health, safety, and welfare of the traveling public; and

WHEREAS, collapse of the immediately surrounding roadway is a likely result should the failed manholes remain unaddressed and continue to deteriorate, exasperated by high volumes of vehicular traffic on White Horse Pike (US Route 30); and

WHEREAS, because of the urgency of implementing the permanent repairs and in order to protect the health, safety, and welfare of the residents of the Borough of Magnolia, an Emergency Contract can be awarded without public advertising for bids pursuant to N.J.S.A. 40A:11-6; and

WHEREAS, the Engineer solicited five (5) quotes on an emergency basis for repairing three (3) manholes on the White Horse Pike with permanent repairs; and

WHEREAS, sealed bids were received by the Engineer on October 27, 2022; and


WHEREAS, the Mayor and Council of the Borough of Magnolia agree that the contract should be awarded to the lowest responsible bidder in accordance with the Local Public Contracts Law N.J.S.A. 40A:11-1 et. seq.; and

WHEREAS, per the recommendation of the Engineer and favorable review of the Quote Documents by the Solicitor, R.D. Zeuli, Inc., located at 288 Pinedge Drive, PO Box 350, West Berlin, NJ 08091, offered the lowest qualified bid; and


WHEREAS, the Acting Chief Financial Officer has certified the availability of funds for the total amount of \$32,742.20, attached hereto.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Magnolia, County of Camden, State of New Jersey, that the emergency contract for the Sanitary Sewer Manhole Repairs project be awarded to R.D. Zeuli, Inc. in the total amount of \$32,742.20.




