**RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MAGNOLIA

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Magnolia, County of Camden, State of New Jersey, that the municipality shall conduct regular public meetings of the governing body on the first Wednesday of each month at 7:00 P.M. at its municipal building located at 438 W Evesham Avenue, Magnolia, NJ 08049 at which formal action may or may not be taken.


