**RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MAGNOLIA
AUTHORIZING A NJ COOPERATIVE PRICING AGREEMENT UTILIZING STATE
CONTRACT 88695 – MULTI-TEMP MECHANICAL, INC**

WHEREAS, the Borough of Magnolia, pursuant to N.J.S.A. 40A:11 et seq., may by resolution and without advertising for bids, purchase any goods or services under any contract or contracts for such goods or services entered on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the State Contract alleviates the need for competitive price bidding by the Borough of Magnolia and, thereby, complies with all bid specifications and bid requirements; and

WHEREAS, the Borough of Magnolia has the need to enter into a Planned Service Agreement; and

WHEREAS, it is recommended that the utilization of the NJ Cooperative Pricing Agreement T1372 Contract #88695 represents the best price available to the Borough; and


WHEREAS, the Borough of Magnolia wishes to enter into a one-year contract with Multi-Temp Mechanical, Inc., for a total cost of \$10,236.00; and


WHEREAS, within thirty (30) days prior to the termination of this contract, the Borough will notify Multi-Temp Mechanical, Inc whether or not the Borough elects to renew this contract. If the Borough does not provide such notice, then the parties agree that this contract will automatically extend for a like period of one year under the same terms and conditions; and

WHEREAS, the Acting Chief Financial Officer has certified the availability of funds attached hereto for a total of \$10,236.00.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Magnolia, County of Camden, State of New Jersey, authorizes a one-year planned service agreement, with the option to automatically extend for a period of one year, utilizing the NJ Cooperative Pricing Agreement T1372 Contract #88695 in the amount of \$10,236.00.






