**RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MAGNOLIA
APPROVING PAYMENT CERTIFICATE #3 & CHANGE ORDER #1 (FINAL) – THINK
PAVERS HARDCAPING – RECONSTRUCTION OF N ALBERTSON AVE & JEFFERSON
AVE**

WHEREAS, on July 21, 2022, Think Pavers Hardscaping, 125 Kings Highway, Mount Royal, NJ 08061, was awarded a contract for the Reconstruction of N Albertson & Jefferson Ave project in the Borough of Magnolia in the amount of \$196,446.00 per Resolution 2022-132; and

WHEREAS, pursuant to Resolution 2023-76, Mayor and Council approved Payment Certificate #1 in the amount of \$69,932.47; and

WHEREAS, pursuant to Resolution 2023-99, Mayor and Council approved Payment Certificate #2 in the amount of \$83,952.95; and

WHEREAS, it has been deemed necessary by the Mayor and Council of the Borough of Magnolia, per the recommendation of the Engineer upon work reviewed and found acceptable, to approve Payment Certificate #3 in the amount of \$34,863.87; and


WHEREAS, change orders pertaining to construction contracts are authorized under N.J.A.C. 5:30-11. et seq; and

WHEREAS, it has been deemed necessary by the Mayor and Council of the Borough of Magnolia, per the recommendation of the Engineer upon work reviewed and found acceptable to approve Change Order #1 (FINAL) in the total amount of \$1,347.96 reduction of the original contract value; and


WHEREAS, it should be noted that the project is substantially complete and retainage in the amount of \$6,348.75 is being held pending completion of items by the contractor and submittal of closeout documents.

NOW, THEREFORE, BE IT RESOLVED, the Mayor and Council of the Borough of Magnolia, County of Camden, State of New Jersey, hereby approve Payment Certificate #3 in the amount of \$34,863.87 to Think Pavers Hardscaping for the Reconstruction of N Albertson Ave & Jefferson Ave project and Change Order #1 (FINAL) for a reduction of \$1,347.96 to the original contract price.


