

**RESOLUTION 2023-172**

**RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MAGNOLIA  
AUTHORIZING EMERGENCY AWARD OF CONTRACT – PERNA FINNIGAN INC. –  
SANITARY SEWER REPAIRS – GLOUCESTER AVENUE**

**WHEREAS**, 350 Lineal Feet of failed 8” Sanitary Sewer Main and 7 Sanitary Sewer Laterals on Gloucester Avenue in the Borough of Magnolia, New Jersey have failed and has sunken into the surrounding roadway, presenting an imminent danger to the health, safety, and welfare of the traveling public; and

**WHEREAS**, the collapse of the roadway is a result of the Sanitary Sewer Main and 7 Sanitary Sewer Laterals failing and continuing to deteriorate on Gloucester Avenue; and

**WHEREAS**, because of the urgency of implementing the permanent repairs and in order to protect the health, safety, and welfare of the residents of the Borough of Magnolia, an Emergency Contract can be awarded without public advertising for bids pursuant to N.J.S.A. 40A:11-6; and

**WHEREAS**, the Engineer solicited five (5) quotes on an emergency basis for repairing 350 Lineal Feet of failed 8” Sanitary Sewer Main and 7 Sanitary Sewer Laterals on Gloucester Avenue; and

**WHEREAS**, sealed bids were received by the Engineer on May 26, 2023; and


**WHEREAS**, the Mayor and Council of the Borough of Magnolia agree that the contract should be awarded to the lowest responsible bidder in accordance with the Local Public Contracts Law N.J.S.A. 40A:11-1 et. seq.; and

**WHEREAS**, per the recommendation of the Engineer and favorable review of the Quote Documents by the Solicitor, Perna Finnigan, Inc., located at 1921 E Sherman Ave, Vineland, NJ 08361, offered the lowest qualified bid; and


**WHEREAS**, the Acting Chief Financial Officer has certified the availability of funds in #C-08-55-812-101 for \$43,327.74 & #3-07-55-502-274 for \$44,444.26 for a total amount of \$87,772.00.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Magnolia, County of Camden, State of New Jersey, that the emergency contract for the Sanitary Sewer Repairs project be awarded to Perna Finnigan, Inc., in the total amount of \$87,772.00.


