**RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MAGNOLIA  
APPROVING CHANGE ORDER #1 (FINAL) SUPPLEMENT 1 & 2 AND PAYMENT  
CERTIFICATE #1 (FINAL) – PERNA FINNIGAN INC – GLOUCESTER AVENUE –  
SANITARY SEWER REPAIRS**

**WHEREAS**, on June 7, 2023, Perna Finnigan Inc., 1921 East Sherman Avenue, Vineland, NJ 08361, was awarded a contract for the Sanitary Sewer Main Repairs on Gloucester Avenue in the Borough of Magnolia in the amount of \$87,772.00 pursuant Resolution 2023-172; and

**WHEREAS**, change orders pertaining to construction contracts are authorized under N.J.A.C. 5:30-11.1, et seq.; and

**WHEREAS**, it has been deemed necessary by the Mayor and Council of the Borough of Magnolia, per the recommendation of the Engineer upon work reviewed and found acceptable, to approve Change Order #1 (FINAL) decreasing the total amount of the original contract value by \$4,900.64; and


**WHEREAS**, Change Order #1 (FINAL) includes Supplement #1, which increases the sum by a total of \$3,093.14; and

**WHEREAS**, Change Order #1 (FINAL) includes Supplement #2, which increases the sum by a total of \$1,500.00; and


**WHEREAS**, it has been deemed necessary by the Mayor and Council of the Borough of Magnolia, per the recommendation of the Engineer upon work reviewed and found acceptable, to approve Payment Certificate #1 (FINAL) in the amount of \$87,464.50, decreasing the total cost of the original contract value by \$307.50.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Borough of Magnolia, County of Camden, State of New Jersey, hereby approves Change Order #1 (FINAL) Supplement 1 & 2, and Payment Certificate #1 (FINAL) in the total amount of \$87,464.50.
