





**RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF  
MAGNOLIA APPOINTING A MUNICIPAL COURT PROSECUTOR**





**WHEREAS**, last year's Public Defender was Michael Bonamassa; and


**WHEREAS**, it was determined that Michael Bonamassa did an exceptional job.
